Responsibilities will include collaborating with the Bank's marketing communications firm, conducting market research (both primary & secondary), and stakeholder outreach. Furthermore, the selected candidate will participate in data collection and analysis, to identify underserved markets in Rhode Island's Infrastructure lending space. Additional responsibilities may include helping to coordinate marketing events for the Bank.

Also, candidates will be expected to assist the Managing Director and other staff members in the daily operations of the Bank's various financial products. Candidates will be given the opportunity to meet major public and private stakeholders in Rhode Island's infrastructure industry to facilitate their research.
