Our Financing Solutions

BROWNFIELDS REVOLVING LOAN FUND

Financing for the remediation of contaminated brownfield sites to return them to productive use.

CLEAN ENERGY FUND

Flexible, low-cost financing for carbon emission-reducing projects for both public and private-sector borrowers.

CLEAN WATER STATE REVOLVING FUND

Affordable, long-term financing for the completion of wastewater, stormwater and other water pollution abatement projects.

COMMERCIAL PROPERTY ASSESSED CLEAN ENERGY

Provides 100% long-term financing for energy efficiency and renewable energy improvements to commercial and industrial buildings.

COMMUNITY SEPTIC SYSTEM LOAN PROGRAM

Provides attractive financing to homeowners for the repair or replacement of failed, failing or substandard septic systems, or to replace a cesspool with a septic system.

DRINKING WATER STATE REVOLVING FUND

Low-interest financing for public water systems, water suppliers and local governmental units to complete drinking water infrastructure projects.

EFFICIENT BUILDINGS FUND

Attractive, long-term financing for the completion of energy efficiency and renewable energy projects.

FACILITY PLAN LOAN PROGRAM

Financing to local governmental units for the completion or updating of water pollution abatement project facility plans.

MUNICIPAL INFRASTRUCTURE GRANT PROGRAM

Grant program providing capital funds for municipalities, and other public entities, to make improvements to public infrastructure.

MUNICIPAL RESILIENCE PROGRAM

Direct support to cities and towns to deploy a planning process which identifies local climate change vulnerabilities and grant funding to implement priority resilience projects.

MUNICIPAL ROAD AND BRIDGE REVOLVING FUND

Affordable, long-term financing for transportation infrastructure projects.

RESILIENT RHODY INFRASTRUCTURE FUND

State sponsored revolving loan program for public entities to address stormwater and flooding events.

SEWER TIE-IN LOAN FUND

Attractive financing to homeowners wishing to connect their residence to a local sewer system and to properly abandon an existing septic system.

STORMWATER PROJECT ACCELERATOR

Provides upfront capital for green stormwater infrastructure projects that will eventually be funded through state and local reimbursement grants.

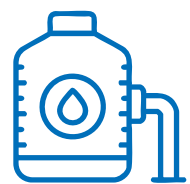

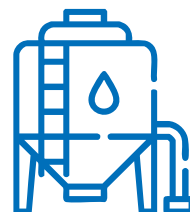

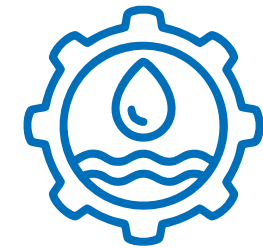

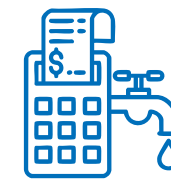

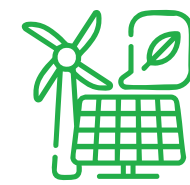

Case Studies



Bringing Clean Water to Scituate Seniors



PARTNER:

Scituate Housing Authority



CHALLENGE

Scituate's Rockland Oaks senior housing complex had been without clean drinking water since 2018. Despite its location within viewing distance of the Scituate Reservoir, the complex was unable to connect to the reservoir — leaving the 23 year-round residents with discolored and contaminated water.



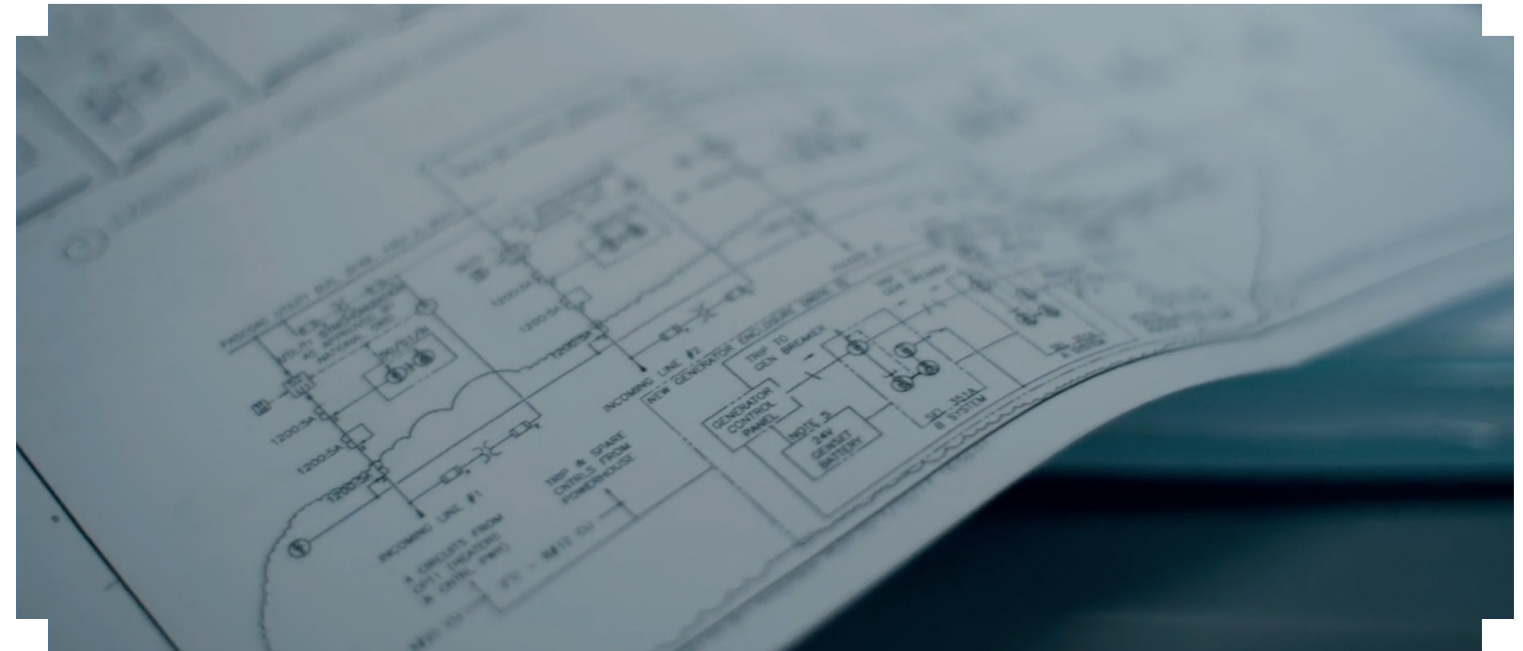
SOLUTION

With a 100% forgivable \$1.6 million loan from the Drinking Water State Revolving Fund, the town of Scituate was able to partner with the Scituate School Department to connect Rockland Oaks to the middle and high school water system.



RESULTS

The upgraded water system and new connection construction will be complete by the end of 2025, bringing clean, potable water to Rockland Oaks seniors and an improved water system to the high school. Funding for this project came from the Infrastructure Investment and Jobs Act (IIJA) of 2021.

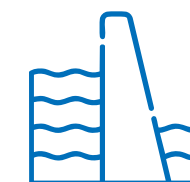


Protecting Cranston's Vulnerable Neighborhoods from Flooding



PARTNER:

City of Cranston



CHALLENGE

In recent years, Cranston's Furnace Hill Brook has been plagued by increasingly severe flooding — threatening the area's historic district and surrounding neighborhoods. Urgent action was needed to build climate resilience and protect from future weather events.



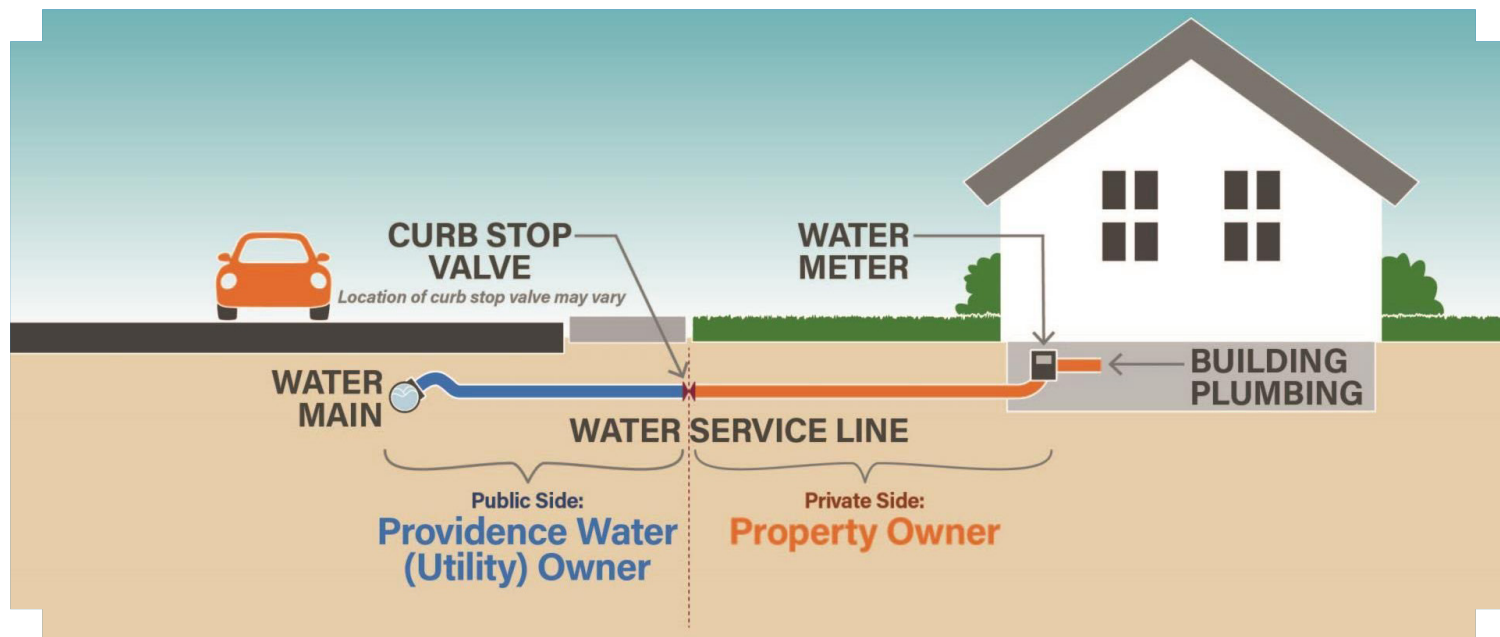
SOLUTION

Thanks to a \$250,000 grant through the Rhode Island Infrastructure Bank's Municipal Resiliency Program, Cranston worked with a skilled firm to design and engineer stormwater mitigation infrastructure along the Furnace Hill Brook waterway.



RESULTS

The project reduces the impact of flooding on main roads near the Brook during weather events, and was designed to account for future precipitation rates, ensuring long-term effectiveness and protection for the area. The nature-based solutions also increased biodiversity and the health of the brook ecosystem.



Replacing Lead Water Pipes for Providence Residents



PARTNER:

Providence Water



CHALLENGE

Legacy lead service lines continue to carry water into thousands of Providence homes, posing a serious public health challenge. As the state's largest water system, Providence Water is leading the effort to replace them, but the scale of work requires significant funding to replace every line while keeping costs low for ratepayers.



SOLUTION

Rhode Island Infrastructure Bank provided Providence Water with a \$26.3 million Drinking Water State Revolving Fund loan, which included \$12.8 million in principal forgiveness subsidies (i.e. grant funding), to advance their Accelerated Lead Service Line Replacement Program.



RESULTS

With this support, Providence Water will continue its vital work to replace lead service lines with safe, modern PVC piping at no cost to residents. Approximately 3,000 lead pipelines have been replaced since 2021, bringing clean drinking water to Providence residents.



Keeping Narragansett Bay Clean



PARTNER:

Narragansett Bay Commission



CHALLENGE

Overflow from outdated sewer networks and legacy pollution from Rhode Island's industrial past have polluted Narragansett Bay, the state's primary body of water and an important site for recreation and shell fishing.



SOLUTION

A \$100 million bond investment from RIIB through the state's Clean Water State Revolving Fund will support the Narragansett Bay Commission's Combined Sewer Overflow tunnel. The more than 5-mile-long tunnel will run under Narragansett Bay and contain sewage overflows.



RESULTS

This decades-long, billion-dollar investment in the health and cleanliness of Narragansett Bay is one of Rhode Island's largest infrastructure projects in history. With a new tunnel, this jewel of the Ocean State will be safe and protected for generations to come.

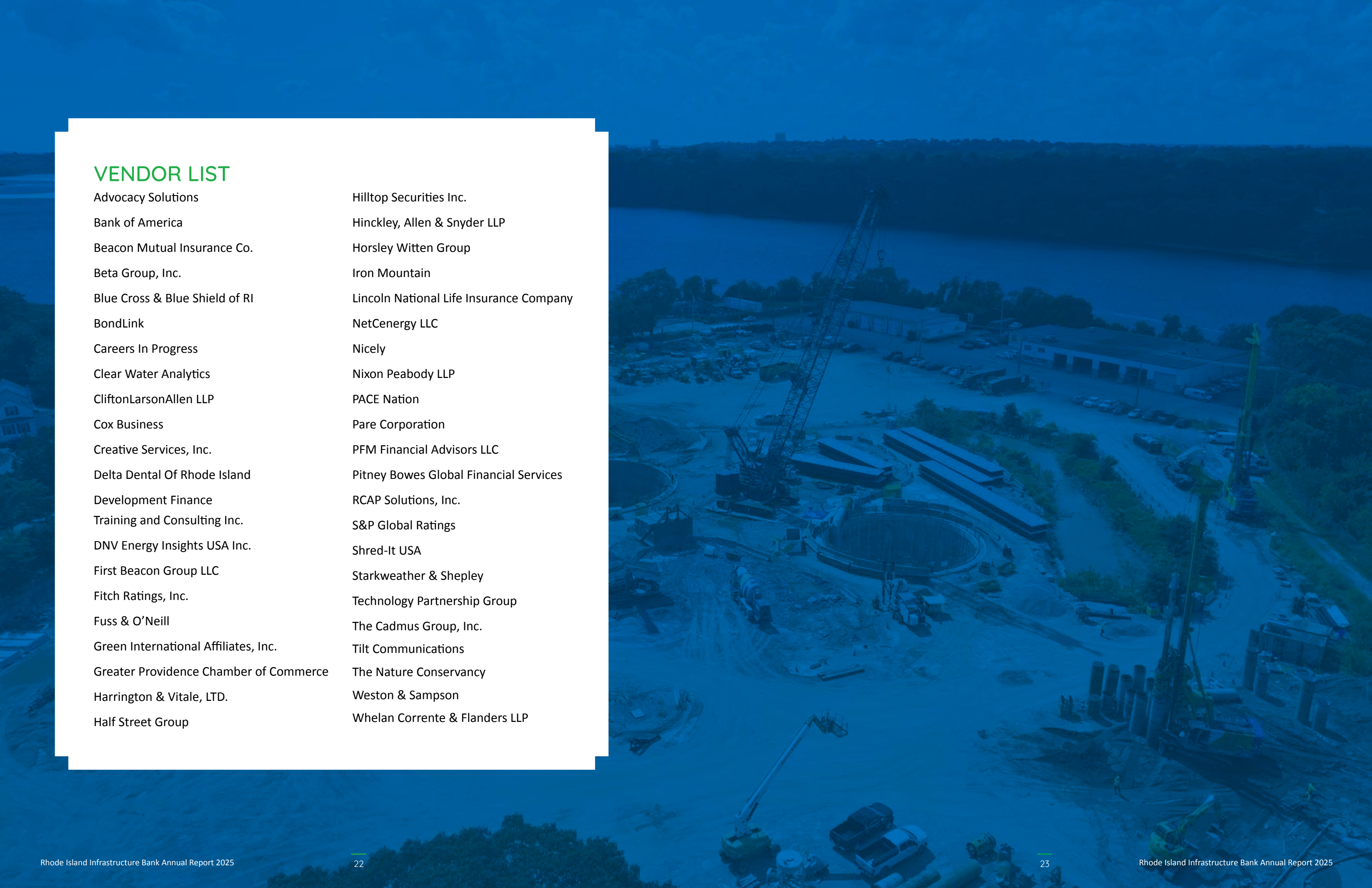

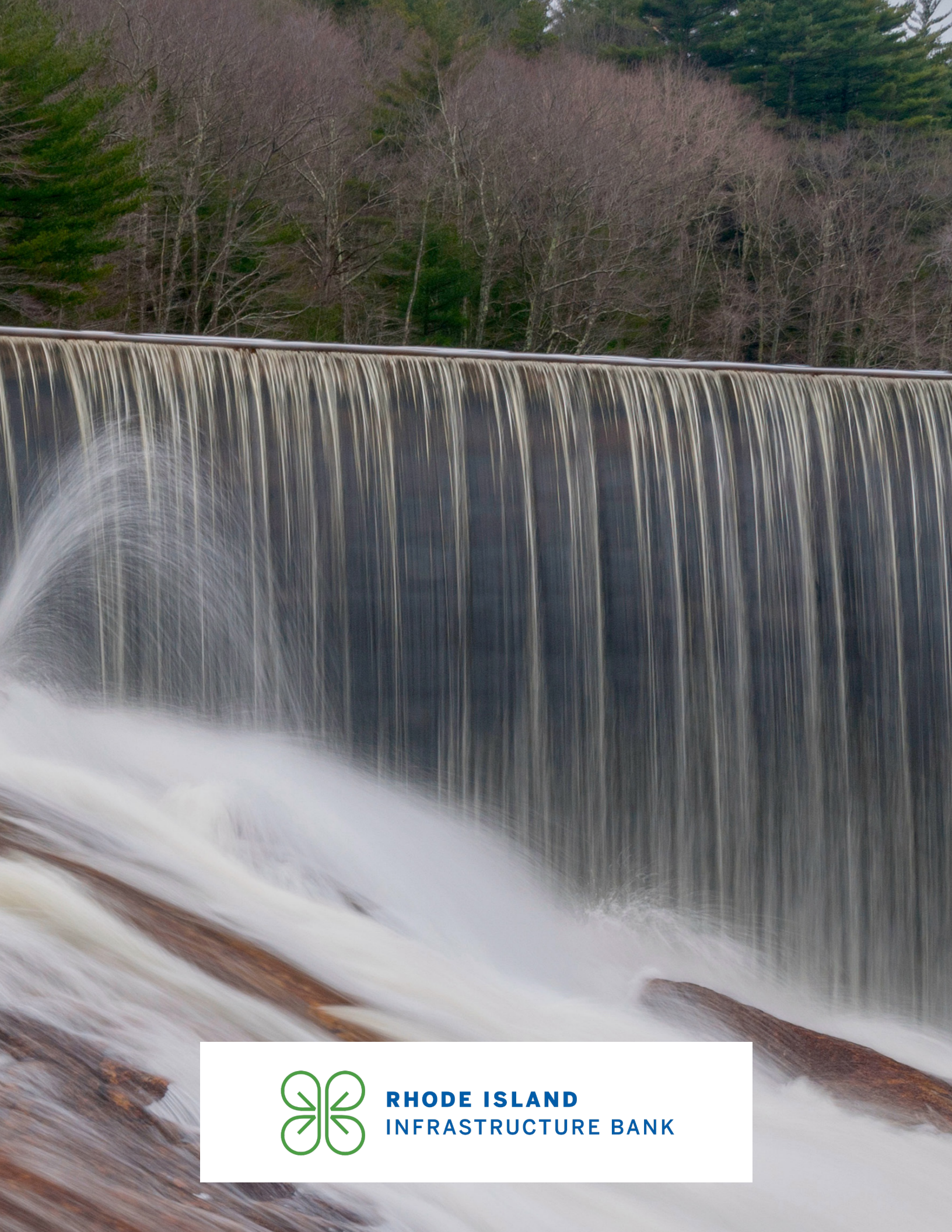
